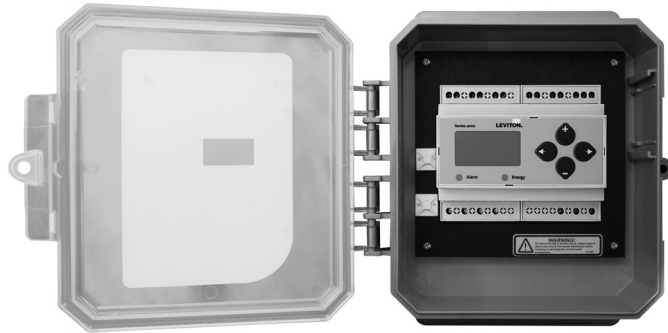

Combinations of serial communication, pulse output and phase alarms are provided to suit a wide variety of applications.

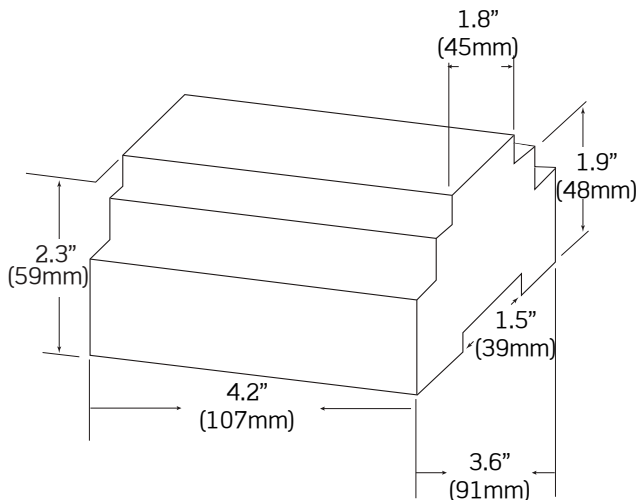

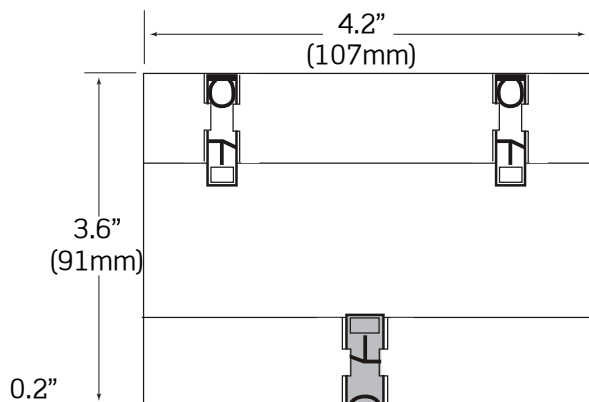

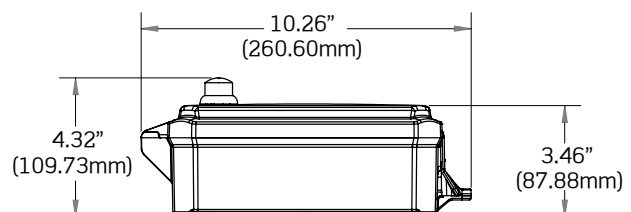
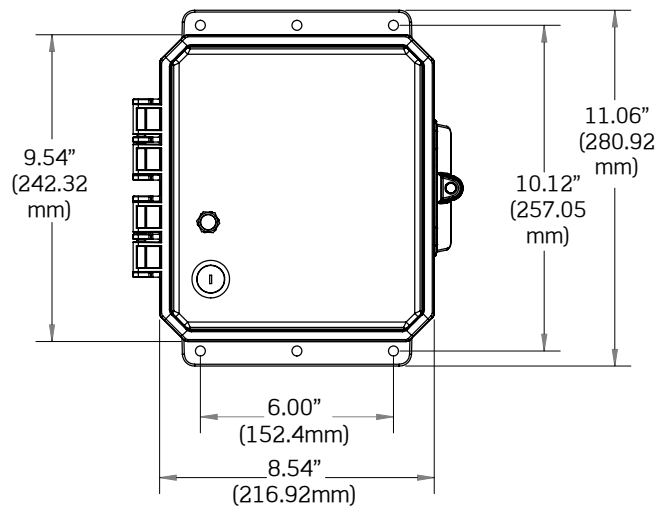
DIMENSIONS - DIN RAIL
